Variation of permitted area and permitted time

- The local government may by notice in writing to a permit holder vary -a) the permitted area; b) the permitted time; or c) both the permitted area and the permitted time, shown on a permit.
- The local government may direct a permit holder to move from one permitted area to another permitted area, if more than one area is specified in a permit.

Duration of permit

• A permit is valid for a period of 3 months after the date on which it was issued unless it is sooner cancelled under this local law.

Cancellation of permit

• The local government may cancel a permit if in her or his opinion the volume of sounds caused by the permit holder in connection with the performance adversely affects the enjoyment, convenience or comfort of other persons in a public place, or if, in her or his opinion of an authorised person, the performance otherwise constitutes a nuisance.

Obligations of permit holder

A permit holder shall not in a public place – a) perform wearing dirty, torn
or ragged clothing; b) act in an offensive manner; or c) place, install, erect,
play or use any musical instrument or any device which emits music
including a loud speaker or an amplifier – (i) other than in the permitted
area; and (ii) unless the musical instrument or devise is specified in the
permit.
